# Guidelines for Developing Student Activity Organization in the Faculty of Fine and Applied Arts, Suan Sunandha Rajabhat University

#### **Absract**

The development of student activities in the Faculty of Fine and Applied Arts, Suan Sunandha Rajabhat University, aims to explore ways to enhance activities that are of high quality and appropriate to the educational context of the faculty. The focus is on promoting key skills for students, such as artistic skills, creativity, teamwork, and the development of management abilities, as well as preparing them for entering the job market in the future. This research employs a survey method to gather data from a sample group of students, faculty members, and staff through questionnaires and interviews to collect opinions and suggestions on activity management in the faculty. The results of the study indicate that the development of activities in the fields of art and culture should receive support in terms of resources and systematic coordination in order to create diverse and valuable learning experiences for students. Furthermore, there should be activities focused on developing skills in management and presenting artistic works, to enhance the students' potential to effectively compete in the modern world.

#### 1. Introduction

The organization of activities in educational institutions plays a crucial role in developing students with a wide range of skills, enabling them to apply these skills effectively in their work and social lives. This is especially true for the Faculty of Fine and Applied Arts, which plays a key role in promoting creativity and developing various artistic skills. Organizing suitable and high-quality activities is therefore a critical factor in enhancing the learning experience for students in the faculty. Students can apply their knowledge and abilities for the benefit of society and themselves (Thidarath Boonnuch, 2000: 3). The goal is to foster and support students in developing desirable graduate characteristics that are nationally or internationally recognized, creating a learning society. The development of learning and the growth of students is a key factor in guiding students toward standards and self-development, as stated by Phaitoon Sinlarat (1996, p. 5).

Suan Sunandha Rajabhat University has the mission to develop students both academically and in various skills to meet the demands of the labor market and contribute to national development. Motivation for learning is the process of stimulating individuals to act in a directed manner toward desired goals, driven by internal stimuli or incentives within the students themselves (Panuwad Kalip, 2022).

The nature of activities should be beneficial and contribute to providing hands-on experiences for students beyond regular classroom learning. These activities aim to develop students into well-rounded graduates with academic and professional knowledge, physical health, and life skills. Moreover, such activities must be promoted and supported by educational institutions (Samnao Khajonsilp, 1999).

Participation refers to the process of involving individuals in developmental activities, including shared thinking, decision-making, and problem-solving by themselves. It emphasizes active participation, problem-solving collaboration using appropriate scientific methods, as well as support and monitoring of the performance of related organizations and individuals (Samnao Khajonsilp, 1999).

However, organizing activities in the present still encounters various obstacles and limitations that may impact the quality and effectiveness of the activities conducted. Therefore, studying approaches to improve the organization of activities to make them more suitable and efficient is essential to fully meet the needs of students and align with educational objectives.

This research aims to explore the feasibility of developing student activities for the Faculty of Fine and Applied Arts at Suan Sunandha Rajabhat University. The focus is on enhancing essential skills and creating valuable experiences for students, which will help increase their potential and prepare them for entering the job market in the future.

# 1.1 Research Objective

- 1. To study the opinions of students regarding the organization of activities within the Faculty of Fine and Applied Arts at Suan Sunandha Rajabhat University and to explore approaches for improving these activities to be effective and aligned with the needs of the students.
- 2. To propose strategies for developing activities that enhance artistic skills, creative thinking, and collaboration skills among students of the Faculty of Fine and Applied Arts, ensuring their quality and effectiveness in meeting the demands of the job market.

#### 2. Literature

Organizing activities within educational institutions plays a vital role in developing students' skills and abilities comprehensively and with quality, preparing them to face challenges in the professional world and in social life. High-quality activity organization significantly impacts the effective development of students, especially within the Faculty of Fine and Applied Arts, which emphasizes fostering creativity and enhancing various artistic skills, such as painting, crafting, design, performance, and music. Activities organized within the Faculty of Fine and Applied Arts not only enhance academic skills but also develop students' social skills, teamwork, and creative expression.

At the Faculty of Fine and Applied Arts, Suan Sunandha Rajabhat University, effective activity organization can strengthen students' abilities and potential to grow fully, particularly in areas such as communication skills, critical thinking, practical application of knowledge, and the development of artistic concepts that are competitive in the real world. Developing high-

quality activities is therefore a key element in helping the Faculty of Fine and Applied Arts achieve its goals in student development, as aligned with the curriculum and teaching objectives.

Effective activity organization thus requires good planning and management, along with collaboration from all stakeholders to create activities that address the development of students' skills and potential comprehensively.

From the study and survey of opinions from students, faculty members, and staff in the Faculty of Fine and Applied Arts at Suan Sunandha Rajabhat University, it was found that many current activities still have weaknesses in various areas. These include a lack of participation from all student groups, insufficiently engaging presentations of work, and a lack of activities that develop management and professional presentation skills, which are crucial in the modern era. Therefore, developing activities that align with preparing students for the future is essential and should be continuously improved and enhanced.

To enhance the effectiveness of activities within the Faculty of Fine and Applied Arts, the process should begin with analyzing and evaluating past activities. This can be done by gathering feedback from all stakeholders to identify the strengths and weaknesses of previous activities. The insights gained can then be used to improve and optimize the organization of future activities. The development of activities should focus on fostering essential skills that students need in the workplace, such as teamwork, creative thinking, using technology for creative projects, and improving time and task management abilities.

In terms of coordination, collaborating with external organizations, such as governmental or private sectors, can help provide resources and opportunities to organize higher-quality activities. Partnerships with businesses or various organizations can create opportunities for students to showcase their work on national platforms, boosting their confidence and developing their professional presentation skills.

Furthermore, activity development should emphasize sustainability by monitoring and evaluating the outcomes of activities after their completion. This helps to assess their impact on students and society and provides valuable insights for improving future activities. Developing activities in this manner will provide students with diverse and meaningful experiences, while also preparing them to enter the workforce effectively.

### 3. Methodology

This research aims to study student participation in activities at the Faculty of Fine and Applied Arts, Suan Sunandha Rajabhat University. A questionnaire, developed based on relevant literature and research, was validated by experts for quality assurance. The target group consisted of 371 undergraduate students from the 1st to 4th year. Data collection took place at

the Faculty of Fine and Applied Arts between February and May 2024, using a 5-point Likert scale questionnaire with interpretation criteria. The data were analyzed using basic statistics, including percentage, mean, and standard deviation, to provide clear research conclusions.

#### 4. Results

The analysis of the data from the survey of 371 students revealed that most students expressed a strong desire for volunteer activities/community service, leadership development activities, and activities related to technology/information/media/media literacy. The average rating for the desire to organize these activities was 4.81 (96.25%).

#### 5. Conclusion

Demographic Information of Survey Respondents The data on the number and percentage of survey respondents classified by gender revealed that the majority of respondents were male (31.81%), while female respondents made up 68.19%. Student Activities From the survey responses of 371 students, it was found that most students expressed high satisfaction with the organization of activities, with an average rating of 4.79 (95.88%). According to Mantana Inthusamit (2006), one reason for the high satisfaction levels with student activities is the students' strong interest in participating. Although students spend most of their time studying, this aligns with the study by Dusanee Tatsanajantanee, Laksanee Meenanan, and Supis Lapthaworn (2003), which stated that students see benefits in various aspects of student activities, such as making more friends, fostering positive attitudes and values toward arts and improving physical health and fitness, promoting culture. and environmental conservation. Reasons for Not Participating in Student Activities. The reasons for not participating in student activities include inadequate publicity about the activities, lack of encouragement or invitation to join, and the time commitment required to participate in these activities.
