And lived for many years and became more children This causes foreign children to have limited access to social services and access to educational services from the government. Because of lack of clear legal status Makes it unable to access basic rights At the same time, there are a number of children and migrant workers who still lack a lot of educational opportunities. As there is no clear way to develop and upgrade the skills of teachers to produce in response to the education of children of foreign workers And the government agreed that education for Thai children or children of foreign workers should be the same. To increase service efficiency And organize teaching and learning activities By using information technology Develop the internet system and focus on the administration according to the good governance curriculum.

Strategy 5 Develop the special target group mission Focus on supervision Achievement tracking and evaluation According to all product and all project / activity indicators In order to make Thai communities abroad to be rich and happy communities with the mission of the Center for Non-Formal and Informal Education

METHODOLOGY

- 1. Regulations of the Ministry of Education on evidence in accepting students. Students enrolled in an educational institution 2005
- 2. Compulsory Education Act 2002 This Act requires that children aged 7 years have to attend school until the age of 16, which is compulsory education. And is a compulsion for parents to send children to school Because parents may be punished according to the law
- 3. National Education Act 1999. This Act is the main law of the state in educational management, which is a law issued under the Constitution of the Kingdom of Thailand.
- 4. Constitution of the Kingdom of Thailand BE 25 to 60, as well as the Constitution of Thailand several previous editions. The current constitution also provides for the right to education, as shown in the section on the rights and liberties of the Thai people in Article 49 which provides that everyone has equal rights to receive education for not less than twelve years that the state will Must provide thoroughly and quality.

The government policy on education for the children of migrant workers there. It's a good policy and is useful to foreign children. But there are still schools and parents of foreign children, not least not aware of the government's policies in education There should be a campaign to let educational institutions and parents of foreign children be aware of the educational policy of the state towards children of migrant workers as well as the benefits from the educational management that occurs to foreign children. Including initial education, free 15-year education, which includes various subsidies from the government, such as tuition fees, school supplies, books, lunch, etc. Although there are policies and laws and regulations that help provide educational opportunities for children alien To encourage the children of foreign workers to be educated in the school system But the education of foreign children is still small Because there is not enough information about the number of people and age groups of foreign children Causing legal rights to receive various services, etc.

- 1. The school shall accept children or persons without evidence of civil registration or without Thai nationality to study. According to the regulations of the Ministry of Education on evidence of admissions to students in the academic year 2005 and document examination. Evidence of civil registration of children or persons applying to study If having evidence of civil registration or 13-digit identification number, proceed in accordance with the normal procedures of the institution. If there is no documentary evidence of civil

registration or a 13-digit personal identification number, follow the steps in determining the student identification code as required by the agency.

- 2. The school shall coordinate the parents of children or persons without evidence of civil registration and 13-digit identification number to collect relevant documents and evidence. Coordinate with the district registration office / local registration office To notify the request to prepare civil registration documents And identity card in the civil registration database under the law on civil registration And use that 13 digit number as a learner database
- 3. When students Students receive a civil registration document. And identity card in the civil registration database (Have received your 13 digit ID) Have the institution edit the information in the student registration in red letters
